Eligibility and Qualifications

To be eligible to receive a scholarship, the applicant's parent(s), legal guardian, or applicants themselves **must have an active membership (primary residence)** with Scenic Rivers Energy Cooperative.

1. The applicant must be enrolling in their first semester of college in the Fall of 2026 and be either:
 - A senior in high school; or
 - A senior in a home-schooled program; or
 - A non-traditional student entering their freshman year in a post secondary accredited program
2. Applicant **must** be present at the SREC Annual Meeting held on April 11, 2026.
3. After successful completion of the student's first semester (Fall 2026) of post-secondary education AND receiving at least 12 college credits at a minimum "C" average for that semester, a \$1,000 check will be made payable to the school for second semester tuition. If the student fails to meet these qualifications, the scholarship will be awarded to the alternate if they have met all the same requirements.
4. To apply, fill out the application and return it to the address below. Application must be received **on or before March 31, 2026**, to qualify. Applications may also be completed online at **sre.coop/scholarship**, through school counselors, or picked up at our offices.
