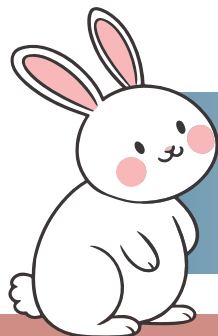
STAY CONNECTED ADD US AS A CONTACT

Zielie's Tree Service will be trimming the Jerrett substation in Grant County during the month of April.
