SMALL CHANGE THAT CHANGES LIVES

ver one hundred donations were made to local organizations through the generosity of our members participating in Operation Round Up. Last month, we shined the light on Cooperative Month and how it pays to be a member of your local cooperative. This month, we are shifting our focus to shine the light on how your small change has changed lives through Operation Round Up.

What is Operation Round Up?

Operation Round Up is a charitable program that allows members to voluntarily round up their monthly electric bill to the nearest dollar. The extra change—typically less than \$6.00 per year—is combined to support local nonprofits, community projects, and hardship cases.

Your Individual Contributions

Each month, once your electric bill is calculated, our billing system automatically rounds the total up to the nearest dollar. For example, an electric bill of \$124.75 is rounded up to \$125.00 —and that extra twenty-five cents goes to the Operation Round Up fund. Contributions range from a single penny to no more than ninety-nine cents per month.

Your monthly contribution is noted under the Billing Summary section on the front page of your electric bill as shown below.

If you want to know how much you contributed in the prior year, look at your January bill – it will include a special message highlighting your total contribution. A summary of past contributions is also available in SmartHub.

What Happens to the Donations?

Operation Round Up contributions are held in a dedicated account, separate from general cooperative funds. The board of directors reviews and approves all disbursements, ensuring the money stays local and goes to worthy causes right here in our service area.

Member Enrollment


Members are automatically enrolled in Operation Round Up when setting up a new account. However, it is a voluntary program and members can opt out at any time by contacting us at 800-236-2141 or through SmartHub.

By pooling our spare change together we can help brighten a child's Christmas, support our local first responders and hospitals, and give a child a comfortable place to sleep. When you choose to round up your bill, you're joining your fellow neighbors to make a meaningful difference in our communities, one penny at a time.

AT RURAL SAFETY DAY

ith safety at the forefront, two crew members spent the day teaching students about the dangers of electrical safety



during Lafayette County's Rural Safety Day in September.

This free event, organized by the Lafayette County Rural Safety Coalition, is made possible through generous donations and the support of volunteers from local businesses.

This year, over 400 fourth and fifth grade students rotated through sessions covering a wide range of topics: electrical safety, skid steer safety, fire and grain safety, boater/water safety, animal safety, weather preparedness, tick/mosquito/bug awareness, UTV/ATV safety, internet safety, and mental health.

Our electrical safety session included a demonstration of the protective equipment our crews wear when working near power lines, an educational video, and a live hotline demonstration.

We're proud to support this event and uphold Cooperative Principle #7: Concern for Community. It's part of our commitment to keeping our community safe especially when it comes to working and playing around electricity.

DUAL FUEL WINER PREPAREDNESS TEST NOVEMBER 19

embers who participate in the dual fuel (offpeak) electric heating program will experience an interruption in the electric heat on November 19, starting at 6:55 a.m. A gradual restoration of electric heating systems will begin at 10:00 a.m. with all systems being restored by 11:00 a.m.

This system-wide test is administered by Dairyland Power Cooperative in advance of the winter full load control season to ensure members' familiarity with the control times and to ensure that backup heating systems are functioning properly for the winter heating season.

Please make sure your backup heating system is operational before this date. If you have questions or concerns, please contact our Member Services Department at 800-236-2141.

Note: This test is for participating dual fuel heat members only. Other controlled loads (i.e., electric water heaters, electric vehicle chargers, agricultural or commercial loads, and electric thermal storage heat), which may be controlled under routine load management procedures will not be affected for this test.
