## **Energy Efficiency**Tip of the Month

Do you have a home office? Set equipment like printers and scanners to automatically switch to sleep or energy-saver mode when not in use. In addition to saving energy, the equipment will stay cooler, which will help extend its life.

Another way to save in the home office is to use energy efficient lamps for task lighting. Small lamps use less energy than whole-room lighting.

## SREC OFFERS COLLEGE **SCHOLARSHIPS**

The Scenic Rivers Energy Cooperative (SREC) Board of Directors will award 52 eligible students with \$1,000 scholarships at our 2023 Annual Meeting. Scholarships will be awarded via a drawing at the meeting held on Saturday, April 15, 2023, in person at the Grant County Youth & Ag Building in Lancaster. At the time of the meeting, applicants will be eligible to receive a scholarship by being either:

- A senior in high school; or
- A senior in a home-schooled program; or
- A non-traditional student entering their freshmen year in a post-secondary accredited program.

#### **Qualifications:**

1. Only dependents of active members or active members of Scenic Rivers Energy Cooperative will be eligible to receive

scholarship money. (Dependents of employees and directors are eligible so long as they are active members of SREC.)

2. The application can be mailed or emailed to the addresses listed below and must be received on or before Monday, April 10, 2023, to qualify:

SREC will mail or email a confirmation receipt to each student who applies. If you do not hear from SREC by April 10, 2023, please call us to verify receipt of your application.

- 3. The student must be present at the Grant County Youth and Ag building for the SREC Annual Meeting on Saturday, April 15, 2023.
- 4. After successful completion of their first semester (Fall 2023) of post-secondary education AND receiving at least 12 college credits at a minimum "C" average for that semester, a \$1,000 check will be made out to the school and the student for their second semester tuition. If the student fails to meet these qualifications, the scholarship will be awarded to the alternate, provided they have met the same requirements.
- 5. Simply fill out the application form at left and return it to the address stated earlier. Applications can also be picked up at our Lancaster or Darlington offices and are available online at www.sre.coop.



that we are doing so because:

- Tree and foliage overgrowth can interfere with power distri-
- Power lines can give off a spark or arc that may land on a nearby branch and ignite.
- The lights in your house may flicker when tree branches brush power lines during high winds.
- Stormy weather can cause nearby limbs to breakoff and land on power lines.
- Unobstructed power lines make it easier and safer for line workers to maintain equipment and restore power.
