JUST THE FACTS: SOLAR POWER BUYING TIPS

Interest in solar systems is growing in our area. Some members are interested in saving money and others are looking for a greener energy source. Others are considering solar energy for both reasons. Regardless of your motive for considering solar panels, we want to help you obtain accurate and current information.

While there are many reputable solar power installation firms in our area, as solar power increases, so do scams. You might consider calling the Bureau of Consumer Protection, (800) 422-7128, or checking

with the Better Business Bureau (bbb.org) to see if complaints have been filed against the business or contractor you are considering.

If an offer sounds too good to be true, it probably is.

Is solar right for you?

To determine whether a solar system is right for you, members should do their due diligence. As your trusted energy advisor, Scenic Rivers can offer a candid assessment of your specific situation. We can look at your average usage and discuss how energy-saving reductions can lead to real dollar savings. It is important for members to remember that even if you reduce the number of kilowatt hours you purchase from SREC, you will still need to pay the fixed charges.

Based on our conversations with members, both prior to and after installations, we believe members should consider the following:

- What is the overall energy efficiency of the home/ building?
- What is the age and pitch of the roof?
- What is the orientation of the sun in relation to the home/ building?
- Is there tree coverage near the home/building?
- What are the projected energy cost savings and is the company using SREC's actual rates and your average usage data?
- Is there a large, up-front payment required or are fees spread out over time?
- Are there any hidden costs, i.e., does the roof need to be replaced before installing the panels?

- Are there ongoing maintenance fees? Who is responsible for the maintenance?
- Does the company carry major insurance for the individuals working on your property?
- How will the new solar system interface with SREC's equipment?
- How is the power safely disconnected, if needed?
- Is special insurance required?
- Is the estimated energy savings worth the investment?
- Is it more cost effective to invest in other energy saving measures? See energy.gov for a tool that can calculate your usage and cost savings.

IN MEMORY OF MERLIN KVIGNE

erlin Kvigne, 1930 – 2023, was quoted stating, "I think our farm was the last farm to get hooked up to electricity in Crawford County" as his family's farm was at the end of a rural road in Ferryville. The year was 1944. Merlin became interested in the cooperative way at a young age, starting with a co-op trip to Madison. He became a director of the Crawford Electric Cooperative and then served through the subsequent merger with Grant-Lafayette Electric. He served a total of 19 years as a board member, ending his career as vice-chairman of the Scenic Rivers Energy Cooperative board.

Merlin was a farmer for many years, drove a fuel truck for a farm service for many years, and eventually—sort of—retired. After that, he began driving for the Crawford County Human Services department (ADRC). He was active in his church, with the school board, and with the school's PTA.

Merlin and his wife, Francille, were married for 71 years. He is survived by three children, five grandchildren, and five great-grandchildren.

Merlin had many fond memories as an active member of Crawford Electric Cooperative and subsequently, Scenic Rivers. Notably, there is rumored to be a photo of his daughter in the arms of then Senator John F. Kennedy, who attended the 1960 Annual Meeting.



Energy Efficiency Tip of the Month

The location of your thermostat can impact your HVAC system's ability to maintain an ideal indoor temperature. For maximum accuracy, thermostats should be placed in the center of the home, away from air vents, plumbing pipes and exterior doors. Avoid placing items like lamps and televisions near your thermostat, which can cause the HVAC to run longer than necessary. Avoid installing thermostats in rooms that tend to feel warmer or colder than the rest of the home. Do not place furniture in front of the thermostat, which can block air flow and result in inaccurate readings.
